# How Harrisville Pharmacy is Reducing Medication Errors and Near-Misses

#### BACKGROUND

Harrisville Pharmacy, an independent pharmacy in Moncton, New Brunswick has a goal to deliver high-quality healthcare, including more than just dispensing medications. They document and analyze any quality related event that may have or has led to potential harm for their patients. This involves multiple stages of the medication management system including prescribing, communications, data entry, packaging, labeling, documentation, education, administration of medications, delivery and monitoring of medication effects.

Andrew Drover, Owner of Harrisville Pharmacy had years of experience maintaining safe pharmacy operations and risk management before opening Harrisville Pharmacy in 2020. He was frustrated with tedious paper systems that required duplicating work onto multiple spreadsheets. Many digital systems also offered only one-way reporting, with no ability to keep historical data in-house, in an easy-toretrieve platform. Drover wanted an easy-to-use system that would provide valuable data he could leverage to improve operations and ultimately chose Pharmapod to be his medication incident reporting platform.
